

## QUALIFICATIONS INFORMATION

Please read the following qualifications carefully before completing the official entry form. The pageant will be held in San Francisco on January 31, 2009. All contestants will be staying at the official Miss Chinatown U.S.A Pageant hotel, in San Francisco during the two weeks, January 25, 2009 to February 8, 2009, when the rehearsals, pageant, and all other Chinese New Year Festivities will be taking place. The Deadline for your entry form and all other required enclosures is Friday, October 31, 2008.

### QUALIFICATIONS OF A CONTESTANT

1. You must be a citizen or a permanent resident of the U.S.A.
2. You must be of Chinese ancestry, meaning your father must be of a Chinese descent.
3. You must be single, never married, and never had a marriage annulled. You must never have been a parent.
4. You must be at least 17 years of age and not over 26 years of age on the date of the pageant. (January 31, 2009)
5. You can be a former contestant of the Miss Chinatown U.S.A. Pageant, but not a title holder.
6. You must be available from January 25, 2009 to February 8, 2009 and participate in all pageant rehearsals and all other required Chinese New Year festivities.
7. You must have a talent presentation for the talent competition phase of the pageant. You must not be or have ever been a "professional" entertainer or model. You are deemed a "professional" if:
  - A. Your federal income tax return states your occupation as an entertainer, a model, a singer, etc.
  - B. More than half of your working time is spent as a performer.
  - C. More than half of your income is derived from performing as an actress, a dancer, a singer, etc.
8. You must be duly sponsored. Sponsorship may be effectuated either before or after you have qualified as a contestant.

Please read the following instructions before completing the official entry form.

1. Print or type information on entry form.
2. Sign your entry form. If you are under 18 years of age, signature of a parent or guardian is required.
3. Enclose a copy of your birth certificate and/or proof of citizenship or residency.
4. Submit the following professional photos for reproduction purposes:

**(IMPORTANT NOTE):** Your picture (s) will appear in various promotional pieces. Please send photos that are very sharp and clear with no special effects or soft filters. Photos must be of professional quality, not digital printouts, and will not be returned to you. You will be notified if the photos you submit are not of good reproduction quality.)

- A. One (1) 5"x 7" Color (headshot) portrait from shoulder up with a light color background.
- B. One (1) 5" x 7" Color full body length in swimsuit from head to toe. A backup copy of the photos maybe submitted on CD (Minimum Resolution is 600 dpi)

5. Submit a 100 word autobiography.
6. Provide a copy of your talent video, VCD, or DVD. Note: Your talent is limited to two (2) minutes and one (1) specialty.
7. Have the sponsorship contract completed by your sponsor.
8. The entry form must be received by the Chinese Chamber of Commerce by 5:00pm Friday, October 31, 2008.
